

ASPERCREME KO BOOMER SWEEPSTAKES OFFICIAL RULES

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR LEGAL RESIDENTS OF THE UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST THE AGE OF MAJORITY IN ENTRANT'S STATE OF RESIDENCE.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. BY PARTICIPATING IN THIS SWEEPSTAKES, ENTRANT AGREES TO BE BOUND BY THESE OFFICIAL RULES ("RULES").

The Aspercreme KO Boomer Sweepstakes (the "Sweepstakes") will commence on August 17, 2026, at 12:00:00 PM Eastern Time ("ET") and ends on September 30, 2026, at 11:59:59 PM ET (the "Sweepstakes Period").

1. SPONSOR/ADMINISTRATOR. The Sweepstakes is sponsored by Chattem, Inc. d/b/a Opella, 21 South Street, Morristown, NJ 07960 ("Sponsor") and is administered by Twelve Thirty, LLC ("Administrator").

2. ELIGIBILITY: The Sweepstakes is open only to individuals who are legal U.S. residents of one of the 50 United States or the District of Columbia, excluding residents of American Samoa, Puerto Rico, Guam, U.S. Virgin Islands and all other U.S. territories, 18 years of age (19 in AL or NE) or older at the time of entry.

The following persons are not eligible to participate: Employees, contractors, directors and officers of Sponsor and Administrator, their parents, subsidiary and affiliated companies, distributors, Web design, advertising, fulfillment, judging and promotion agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, "Sweepstakes Parties"), including its affiliates and agents, and their respective immediate family members (spouse, parent, child, sibling, grandparent, and/or "step") of each and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes). The Sweepstakes is subject to all applicable federal, state, and local laws, regulations, and ordinances.

3. HOW TO ENTER: There are two (2) ways to enter the Sweepstakes: (a) via online form ("Online Form") accessible via KOBoomer.com (the "Website") or through Sponsor's digital promotional materials ("DPM"), and (b) via Alternate Method via mail-in.

- a) **ONLINE FORM:** To enter via Online Form, entrants must first visit KOBoomer.com. Upon reaching the Website during the Sweepstakes Period, follow the instructions to complete and submit the entry form which may include but not limited to, submitting entrant's birth date, email, phone number, first and complete last name (no initials), street address (no P.O. Boxes will be allowed), city, state, and ZIP Code, and checking the required consent boxes presented. Once entrant has completed the foregoing, entrant will have earned one (1) entry ("Entry") into the Sweepstakes. Any Online Form Entry that is submitted after 11:59:59 PM ET on September 30, 2026 will be disqualified and that entry attempt will not be eligible for a prize random drawing.
- b) **ALTERNATE METHOD:** To enter the Sweepstakes without completing the Online Form, an eligible entrant must hand-write his/her complete first and complete last name (no

initials), email address, telephone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: Aspercreme KO Boomer, 47 W Division St., #374, Chicago, IL 60610. All Mail-In Entries must be postmarked no later than September 30, 2026, and received on or before October 6, 2026, in order to be eligible. Each Mail-In Entry is worth one (1) entry into the Sweepstakes. An Entrant may not submit via the Alternate Method in addition to the Online Form method mentioned above.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries

Entries may be referred to herein individually as an "Entry" or collectively as "Entries."

Limit one (1) Entry per person/email address during the entire Sweepstakes Period, regardless of method. By submitting your Entry, you confirm that you are eligible to participate and are in compliance with these Rules.

To be eligible for a prize, the Entry must be in English and be in complete compliance with these Rules. Neither Sponsor nor Administrator are responsible for lost, late, incomplete, tampered or damaged Entries or Entries that are lost or misdirected to any Junk folder or SPAM filter. All such Entries will be ineligible. Such Entries will not be acknowledged or returned. Entries become the property of Sponsor. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address, if any, and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

In the event of a dispute over who an Entry corresponds to, the authorized account subscriber of the cellular account or email address used to enter the Sweepstakes as of the actual time that such information was received by Administrator, will be deemed to be the entrant. The "authorized account subscriber" is defined as the natural person who is assigned the cellular telephone number or email address by the cellular telephone network associated with the cellular phone number or by the internet service provider associated with the email address used to enter the Sweepstakes. Administrator may require an entrant to show proof of being the authorized account subscriber. Sponsor and/or Administrator are not responsible for cellular carrier or cell tower glitches or outages that result in the non-receipt of any entrant's Entry attempts. Sponsor and/or Administrator are not responsible for Entries that are garbled, corrupted, or otherwise unascertainable or incomprehensible. Entrants may be required to indicate their acceptance to the Rules where indicated at the time of Entry; provided, however, that any entrant's participation in the Sweepstakes constitutes, and is deemed, such entrant's full and unconditional agreement to the Official Rules and any and all decisions of Sponsor and Administrator, which are final and binding in all respects. All entrants agree to waive any right to claim ambiguity in the Sweepstakes and/or these Official Rules. Entries not in compliance with these Rules may be disqualified in

Sponsor or Administrator's sole discretion. If you choose to enter via a mobile device, STANDARD MESSAGE RATES AND DATA CHARGES APPLY. Please consult the terms and conditions of your individual service plan prior to participating via a mobile device. A mobile device is not required to enter the Sweepstakes.

4. WINNER SELECTION AND NOTIFICATION: On or about October 8, 2026, one (1) winner will be selected in a random drawing from among all eligible Entries received during the Sweepstakes Period.

The odds of winning depend on the number of eligible Entries received during the Sweepstakes Period. The random drawing will be conducted by Administrator, whose decisions are final in all matters relating to this Sweepstakes.

The potential Winner will be notified by email within ten (10) days of the random drawing (a "**Prize Notification**"), and the potential Sweepstakes Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within three (3) calendar days of Prize Notification, or the prize may be forfeited in its entirety and awarded to an alternate winner at the Sponsor's sole and absolute discretion. Failure to respond to the Prize Notification, return all required forms within 3 days, or comply with any other provision of these Rules may result in a winner being disqualified and an alternate winner may be selected. If a Prize Notification or a prize is returned as undeliverable for any reason, an alternate Winner may be selected by random draw from all remaining eligible entries at the Sponsor's discretion. If the Sweepstakes Prize is forfeited for any reason, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining non-winning Sweepstakes entries, as determined by Sponsor in its sole discretion. All of Sponsor's decisions are final.

No more than the number of Prizes listed in these Rules will be awarded.

The prize will be sent to the address provided by the potential Winner upon verification. Sponsor shall have no liability for any Prize Notification that is lost, intercepted, or not received by the potential Winner for any reason. In order to claim a prize, the potential Winner may be required to verify for Sponsor his or her permanent address and social security or taxpayer identification number, for purposes of compliance with tax regulations.

Administrator will issue an IRS Form 1099-MISC to the Sweepstakes Prize winner for the value of the Sweepstakes Prize. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won.
